- 1) What are the hazards/injuries involved with Forklifts?

- **2)** What hazards should be recognized?
 - a. Proper maintenance
 - b. Alarms & sounds
 - c. Training
 - d. Speed
 - e. Load limits
 - f. Pinch Points
- **3)** What safe practices should be used when operating a forklift?
 - a. Separate forklift traffic and foot traffic where possible
 - b. Do not operate the forklift unless you are trained and authorized to do so
 - c. Make sure backup alarms and lifting alarms are operational
 - d. Be aware of blind intersections and pedestrians
 - e. Perform pre-shift inspections of your forklift
 - f. Report any unsafe conditions immediately
 - g. Be aware of pinch points in wheels and lift gears
 - h. Wear your seatbelt
 - i. Stay inside the cab if the forklift tips or rolls over
 - j. Do not drive up to anyone standing in front of a fixed object
- **4)** Do we have any forklifts in need of repair or maintenance?
- **5)** Who do we report forklift problems to?
- **6)** Do all of our backup alarms work?
- **7)** Where are other pinch points on the forklift?
- **8)** Has anyone been in an accident or near miss while operating a forklift?
- **9)** Do we use a pre-shift inspection prior to each shift?
