

Toolbox Safety Talks

Road/Street Work

- 1) What are the hazards/injuries involved with road work?
 - a. Being struck by vehicles resulting in serious injuries and/or death
- **2)** What hazards should be recognized?
 - a. Warnings
 - b. Signs
 - c. Traffic Control
- **3)** What safe practices should be used when working on or near roads?
 - a. Cone off a tapered lead in zone to control traffic
 - b. Ensure barriers are erected around excavations, and that lighting/warning lights are used at night
 - c. Ensure a suitable pedestrian route is maintained if necessary re-route
 - d. Clean any excess mud/debris off the road so far as is practicable
 - e. Beware of work activities that create dust or debris that may impact on vehicular or pedestrian routes
 - f. Position plant and equipment so that no part of it infringes on the safety zone, and do not store any materials or equipment in the safety zone
 - g. Consider and organize site traffic access/egress
 - h. Wear safety helmets, hi-visibility vests and safety footwear
 - i. Do not enter the safety zone unless specifically required and authorized to do so
 - j. In the summer consider protection against the sun.
 - k. Consider precautions for working in excavations, underground services, etc
 - 1. Suitable warning signs should be displayed and correctly positioned
 - m. Traffic control must be implemented to meet the site requirements
- **4)** Does everyone have a high visibility vest for road work?
- **5)** Do we have the proper signage and warning devices for road work?
- **6)** Has anyone ever had an incident or near miss while performing road work?
- **7)** Are there any other safety issues you would like to discuss?
