Traffic Control

- **1)** What are the hazards involved with traffic?
 - a. Mobile equipment Accidents
 - Fractures
 - Death
 - Property damage
 - Equipment damage
- **2)** What hazards should be recognized?
 - a. Excessive speed
 - b. Crossing traffic lanes
 - c. Traffic congestion
 - d. Poor road/berm conditions
- **3)** What safe practices should be used?
 - a. Follow all site rules and signs
 - b. Watch your speed and stay in your lane
 - c. Be aware of other mobile equipment, site visitors, equipment, and people on foot
 - d. Check your equipment before use (pre-shift inspection)
 - e. Check your brakes each time you approach a steep grade or elevated dump
 - f. Never move or change direction without using a warning signal or flagger
 - g. Report any unsafe roadway conditions immediately
- **4)** Where do we post our traffic rules? What are they?
- **5)** Where are our high hazard areas? Is there a way to relieve the hazard?
- **6)** Which of our grades require brake checks? Are signs posted?
- **7)** If you are relieving someone only for a short period of time, do you need to check the equipment?
- **8)** What are our procedures for reporting someone violating our traffic procedures?
- **9)** Has anyone been in or witnessed a mobile equipment incident or near miss?
- **10)** Are any signs missing or in need of repair on our site?
- **11)** How are our road berms?
