

## **Toolbox Safety Talks**

## **Trash Handling**

- **1)** What are the hazards involved with trash handling?
  - a. Strains & sprains
  - b. Lacerations
  - c. Slips, trips, falls
  - d. Infectious disease
- **2)** What hazards should be recognized?
  - a. Overloaded bags and/or containers
  - b. Broken bags and/or containers
  - c. Improper bags and/or containers for the waste
  - d. Slip or trip hazards near the dump site
  - e. Sharp objects in the trash
- **3)** What safe practices should be used?
  - a. Limit excess compacting waste in containers, do not use hands or feet
  - b. Never dig through waste containers
  - c. Limit the size of your waste bags and/or containers to a size that can easily be managed by your employees
  - d. Never overfill bags or containers
  - e. Provide shielding or other means of protection for glass or other sharp objects prior to putting them in the waste container
  - f. Keep bags and/or containers away from your body when moving or carrying
  - g. Use bags with built in handles or tie the bag in such a way that you have a handle
- **4)** Why should we never dig through the garbage?
- **5)** Do we have any waste containers that are inadequate or hard to move?
- **6)** Has anyone ever been injured while taking out the trash?
- **7)** Do we keep the area around the dumpster free of debris, ice, and spills?
- **8)** Give an example of how you would dispose of a broken bottle?
- **9)** How could an infectious disease be transmitted from person to person through the trash?
